

Funding guidelines for micro-projects

The German Embassy in Hanoi and the German Consulate General in Ho-Chi-Minh-City can fund micro-projects that aim at sustainably improving the living conditions of poor and marginalized communities, contributing to gender equality and promoting the Sustainable Development Goals (SDGs) contained in the 2030 Agenda for Sustainable Development adopted in 2015.

Projects are eligible for funding if:

- the applicant is a local non-governmental organisation, self-help group, local church or similar. Applications submitted by individuals or businesses will not be considered. The applicant and the local population should make their own contribution as far as possible;
- local authorities have approved of the implementation of the project;
- they can be completed by December 31st 2024;
- the applicant contributes to the project by means of finances, labour, providing premises etc.;
- the requested project aid ranges between 8,000 and 15,000 EUR (equivalent in VND depending on the exchange rate); in exceptional cases funds can amount up to 20,000 EUR.

Projects are not eligible for funding if:

- the project results in recurring obligations for the Embassy or the Consulate General (e.g. ongoing requirement to pay salaries or for consumer goods such as animal feed, medicines, substances/agents, paints, etc.);
- the project has already commenced;
- follow-up costs cannot be borne by the applicant or the project is expected to have effects for less than three years
- the project is intended for food or humanitarian aid during disaster and crisis situations.

Applications can be submitted in German or English language under the heading "micro-project" to the competent German mission:
